The House Officer (Community) will report to the designated Primary Care Physician II in his/her area of assignment.	The House Officer (Community) is responsible for diagnosing and administering general medical treatment to patients in a health facility or through extension services at a clinic, school or clinic mobile or another designated place. Work involves the examination of patients, diagnosing, advising and carrying out necessary treatment in the investigation, eradication, prevention and control of diseases, or referring complicated cases for further professional attention. He/She performs under the general supervision of a professional superior who is available for consultation and is reviewed through observation, consultation and analysis of findings and reports.
